It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

Effective January 1<sup>st</sup>, 2011, CKC has implemented a Non-Member Participation Fee of \$62.40 + HST. This fee only applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

Entries open September 11, 2017 at 12:00 pm and close Friday, October 27, 2017 at 9:00 pm. All entries received after closing will have an extra \$3.00 per run applied. Day of entries will be taken up to 1 hour before the trial starts.

### Entry Fees:

Early Bird cost is \$22.00 per run or 3 runs for \$65.00 until October 13, 2017. Entries received between October 14 and October 27, 2017 will be \$26.00 per run or \$75.00 for all 3 runs. Entries received any time after October 27, 2017 (including day of show entries) will be an extra \$3.00 per run. Fun run cost is \$10. Listing fee, per dog per trial \$8.50 (payable ONLY if no CKC registration #, ERN or PEN is available for the dog). Please note: each agility entry includes a \$4.70 CKC Recording Fee

Effective for all SPD trials held after January 1st, 2015, exhibitors entering online will be charged 10% online entry fee. This fee will be charged for any entries that are not received in hardcopy

The Trial Secretary is in full charge of the Trials. Trial precincts consist of the trial building. Whistles, flexis and prong collars are NOT permitted in the building. Please no food, toys or clickers near the ring. Bitches in season are NOT permitted anywhere on the trial grounds. Ring is Top Dog rubber agility flooring with underlay. Ring dimensions are 100 ft x 90 ft. NO OUTDOOR SHOES ARE ALLOWED IN THE BUILDING. Handlers in all classes may walk the course without their dog prior to the start of their class. There will be NO obstacle familiarization. Obstacles shall meet the specifications in the CKC Agility Rules & Regulations effective January 1<sup>st</sup>, 2014.

To be eligible to compete in these trials, a dog must be 18 months of age and eligible for a registration with the CKC, have an ERN or CKC Misc. Certificate or a CKC Performance Event Number. Spayed bitches, debarked dogs and neutered males are eligible to compete. Mixed breed dogs may enter these trials with a CKC Canine Companion Number.

Bitches in season may not compete. When a bitch comes into season after the entry has closed, a Vet's certificate certifying the bitch was in season within a 10-day period preceding the trials must reach the trial secretary on or before the start of the first trial. A full refund of entry & listing fees will be given, however the 10% online entry fee will not be refunded (if applicable).

Unfortunately, we can NOT refund entries after closing for any other reason. Anyone wishing to pull their entries after closing may upon request receive a 50% credit (excluding the additional 10% online entry fee if applicable) toward future SPD entry fees for another trial held within twelve (12) months of this trial.

No entries will be accepted, altered, cancelled or substituted after the official closing date and time for entries, except as provided in the rules. Exhibitors must abide by errors made in entering their dogs regardless of how and by whom the errors were made.

Entries will be accepted only if accompanied by the correct fees. Courier entries will be accepted if no signature required. Tendering of an NSF cheque is considered non-payment of fees and is punishable by disciplinary action. A \$30 NSF service charge will be applied.

Move ups will be allowed if received 1 hour prior to the start of the class being moved into.

Flat carded & stringed ribbons will be awarded for qualifying scores & 1<sup>st</sup> through 4<sup>th</sup> placements. New title rosettes are available for purchase at our cost of \$7.00 each.

Foreign Exhibitors please note that fees are due and payable in Canadian dollars. Due to fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, in US funds. Please do not mark personal cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you.
