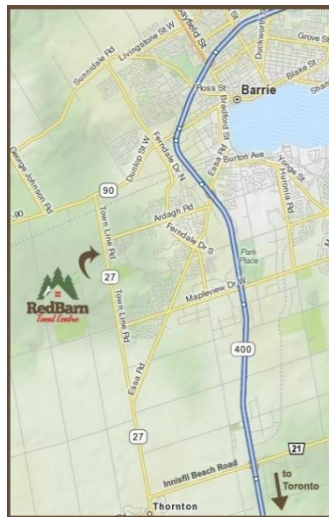

Directions to
The Red Barn Event Centre:

From the 400: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go South on County Road 27.(aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From CR 27 South: Follow CR 27 northbound through Thornton. Continue north. After 5 minutes, look for signs on your right that show you have to turn LEFT to stay on CR 27. When you see that sign, turn left, continue on CR 27. When you come down the big hill look for our white flags on the west (left) side of the road. If you get to lights at Ardagh, you’ve gone too far.
