5. *With the official release of amendments to O. Reg. 364/20 Rules for Areas at Step 3, and after consultation with our local health unit SMDHU (that we have worked so closely with throughout this pandemic), Red Barn Event Centre and Simcoe Performance Dogs has received confirmation that we will be required to ensure any person 12 years of age or older who participates in an event must provide proof of identification and of being fully vaccinated against COVID-19. This will apply to any indoor events at Red Barn, and will come into full effect on Wednesday, September 22, 2021. It applies to ALL persons over the age of 12.*

GENERAL INFORMATION

This trial is being held under the Agility Association of Canada Inc (AAC) rules and regulations. Exhibitors by submission of entry, acknowledge that they are aware of these Regulations.

Move ups on the day will be permitted.

This trial will be held indoors on rubber matting in a 90 ft by 90 ft ring at the Red Barn Event Centre, Barrie, Ont. Agility Equipment will be chosen from those described in the AAC Rulebook. Rubberized contacts and E-timing will be used.

All dogs must be on leash at all times unless competing in the ring. Dogs must be under control at all times, each person is responsible to ensure their dog is behaving correctly, if not, you will be asked to leave the venue. You must clean up after your dog, if found not to, future entries will be refused.

Please no dogs in the café or washrooms.

No unauthorized vendors or photographers.

Eligibility

This trial's organizing committee reserves the right to refuse any entry and is in full charge of the trial. This trial is open to all dogs being at least 18 months of age, including purebred and non-purebred, except bitches in season, dogs suffering from any deformity, injury or illness that may affect the dog's physical or mental performance, or dogs exhibiting signs of aggression towards people or other dogs.

Refunds

There shall be no refunds for entries withdrawn after the closing date or in the event the dog is absent on the day of the trial. If the dog and/or handler are dismissed from competition, regardless of the reason for such dismissal, there will be no refund. Any handler who is found to abuse a dog will be disqualified and dismissed.

Full refunds will be given for withdrawals before the closing date. Full refunds for withdrawals of bitches in season or injured dogs with a Veterinarian's note received by the trial secretary prior to the trial.

All competitors participate in the events at their own risk. The AAC General Agreement/Disclaimer must be agreed to on AgilityRocks in order to comply with AAC's acceptance and acceptance to this trial.

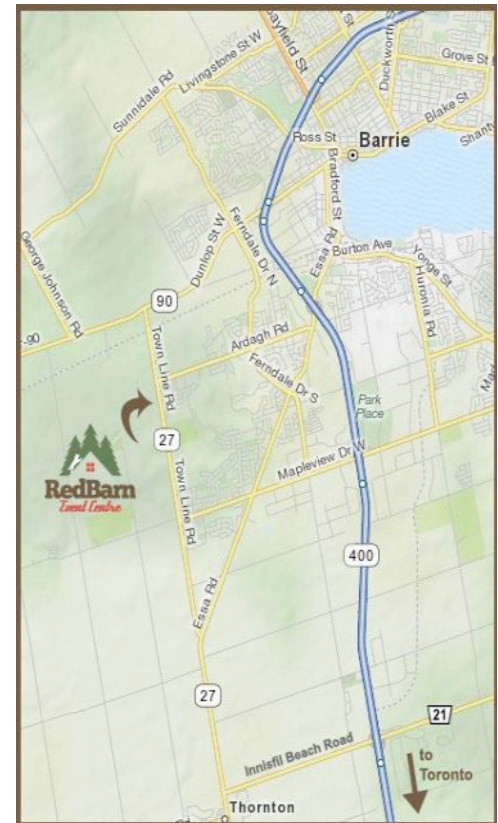

From the 400: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go south on County Road 27. (aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From Hwy 27: When traveling north on CR 27 you must turn left shortly after passing through the town of Thornton. Look for the 20th Sideroad on your left and then the 10th Line on your right, that's your cue to slow down. Then you will see a small sign on your right that shows you must turn left to stay on CR 27. Turn left on CR 27 and continue north. After passing Mapleview Dr. W. you will go down a big hill, the Red Barn flags are on your left at the bottom of that hill

(AAC) in the effect at the time of this entry, and by any additional rules and regulations appearing in the Agility Trial Schedule for this event. I certify and represent that the dog entered is not a hazard to persons or other dogs. This entry is submitted for acceptance on the foregoing representation and General Agreement/Disclaimer. I agree to conduct myself (ourselves) in accordance with such Official Rules and Regulations (including all provisions applying to discipline) and to abide by any decisions made with them.
