**Entry fee per dog per event: Before closing .....\$65.00 for all 3 runs, includes HST**

**Exhibition Only (dogs not entered but on the event grounds) ..... \$13.30 includes HST**

**TCN fee per dog per run..... \$11.30 includes HST (this fee is charged by the CKC)**

**Please note: each entry fee includes the CKC Recording Fee of \$4.70 + HST. All fees are payable in Canadian Funds.**

**Payment:** No invoices will be sent, you must pay trial fees immediately after entering. Confirmations will be sent once payment is confirmed, please do not send emails to secretary to confirm. Send electronic transfer to: [sprinterspd@gmail.com](mailto:sprinterspd@gmail.com) (please put sprinter October 5 in comments, if you are queued to give a password please use the word sprinter. No credit cards will be accepted. If you submit payment to the wrong email address there will be an additional \$10 processing fee as it is significant work for us to track down the payment and transfer it. Once payment is received you will receive a confirmation from the Red Barn. If you don't get a confirmation within 72 hours of payment email [sprinterspd@gmail.com](mailto:sprinterspd@gmail.com) Please do not email secretary to confirm receipt until the 72 hour time period is over. Unpaid entries will be deleted without notice. Cheques will not be accepted due to the short turnaround time of this trial. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Females in season or lame dogs will be excused and their entry fees refunded provided notice is given prior to or during roll call.

**Trial information and running order will be emailed out to competitors no later than 4 days before the event date. PLEASE contact Dara Murphy trial secretary [sprinterspd@gmail.com](mailto:sprinterspd@gmail.com) prior to the September 9<sup>th</sup> if you have not received an emailed confirmation from us.**

Competitors will be put into 'heats' of approximately 20 dogs per hour. Competitors can only handle 2 dogs max per heat. Competitors with greater than 2 dogs (this includes helping someone else as releaser or catcher) will be accommodated in sequential heats. Competitors cannot request specific heats. Competitors will need to be present and ready to run dog in assigned position, failure to do so will forfeit your run without refund. You will be provided an approximate time to arrive and the approximate time your runs will be scheduled. You must leave when your runs are completed. Due to Covid 19 we can only allow a limited number of dogs and people on the premises. You will be asked to leave if you are not there at the appropriate time. We truly appreciate your understanding in this issue.

**We thank you for your understanding in maintaining social distancing during this event**

**Rules (by entering this trial you are confirming that you have read and will abide by these rules):**

- Red Barn Event Centre Speed limit on the grounds is 10km/h; anyone not in compliance with this will be asked to leave with no refund of entry fees.
- Event will be outdoors on grass 100 metre straight-line plus start and finish areas
- Shade is not provided, food or water is not provided, please bring food and water for your dog (Covid 19)
- Snow fencing (soft plastic) is used along the 100m track
- Equipment will be continuous loop lure with plastic bags & electronic timing will be used
- Dogs must be **ON LEASH** at all times except during their run. There will be a \$20 fine for any loose dog interfering with a course in progress.
- We ask handlers and dogs use the pond pathway when going to and returning from the finish line.
- All dogs will run individually and will have a maximum time of 60 seconds for their run.
- You **must** have a 2<sup>nd</sup> handler present with you to release or catch your dog. BOTH 'releaser' and 'catcher' must be listed on the entry form (Covid 19 requirement). Both must have a leash.
- Heats will have approximately 20 dogs, handlers must be able to handle (release or catch) dogs within the heat.
- Inform the Trial Secretary with your entry if your dog is difficult to catch at the end. Notify the Gate Steward before your run and a catch chute will be used for all dogs that are difficult to catch at the end of their run.
- The event will be run in heats of up to 20 dogs/hour each dog gets 3 runs if entered. Once your heat is completed, you must leave so the next heat can enter the premises.
- Once you enter the parking lot please go to the check in desk with your dog so we can check you in and do the lameness test #1.
- All competitors must have 2 leashes (one at start line and one at finish line with the catcher.) All competitors must fill out who they will be working with for catching and releasing on the entry form. Releasers and catchers must wear closed toed shoes for safety reasons. No exceptions.

**Checking in (many things are new due to Covid 19)**

- Briefing: You will receive a link to a video briefing prior to the trial. You must watch this briefing as due to Covid 19 restrictions we cannot do the briefing at the event. - You will be emailed a pdf check in card. **You are responsible for printing out this page.**
- When you arrive go to the check in station for lameness and in season check and receive your sticker run 1. You will proceed to the area designated to be ready for your run and show your card to gate steward. Immediately following your run, you will receive you next lameness check by the wrangler at the start line and will receive your 2<sup>nd</sup> sticker, this will be repeated for your 3<sup>rd</sup> run. You will not be allowed a run if the ticket is not stamped for the next run.
- You must be ready for your run or it will be forfeited with no refund. Due to Covid 19 we can only have a limited number of people on site so unfortunately, we cannot be flexible.

**Ribbons**

- When you finish your 3 runs please copy your times down at the finish line (or even better, take a picture with your phone). Return to the main check in station and report the number of qualifying scores you have completed. Your qualifying ribbons will be placed in box so you can take them out at a safe distance. When you have completed all runs you **MUST** leave the property so we can let the next group in.
- **New title rosettes** will be offered at a cost of \$10.00 per rosette, exact change only & pick up before you leave.

**Results**

You are responsible for bringing something to copy your time and note of qualification. A helper at the finish line will show you your time once you catch your dog. We will also be providing results in real time to our website, [http://redbarneventcentre.com/competitions\\_events.html](http://redbarneventcentre.com/competitions_events.html) you will need a device with mobile data to obtain this at the trial. Weather dependent we will have a monitor available for checking your results. Please note social distancing must be observed at this site. You are responsible for noting your time and making your own calculations of points as found on the CKC website at <https://www.ckc.ca/en/Files/Forms/Shows-Trials/Event- Rules-Regulations/Sprinter-Rules-and-Regulations-Effective-January-1> You are responsible for documenting and saving your results, please do not contact the trial secretary for results in the future. The club will send in the calculations to the CKC who will send out titles earned. Placements & final results will be emailed to competitors after the trials only.

## Refunds

Anyone wishing to pull their entries after the closing date will receive a credit in the amount of 50% of their entry fees, excluding the online entry service charge if applicable) towards a future SPD CKC event held within twelve (12) months of this trial. In case of public health restrictions that prevent the event occurring a full credit will be provided to your account to be used within one year. No refunds will be issued.

**VOLUNTEERS:** They are essential to help run these events, so we can all enjoy our dogs having fun. Please consider volunteering at these events or providing a volunteer, learn to work as a starter, timer, begin learning about lure operating or helping other exhibitors with releasing or catching. You must let us know ahead of time.

## Directions to the Red Barn Event Centre, Barrie, ON:

**GPS coordinates: lat 44.344860 long -79.741025**

From the 400: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go South on County Road 27 (aka Town Line Road).

Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From CR 27 South: Follow CR 27 northbound through Thornton. Continue north. After 5 minutes, look for signs on your right that show you have to turn LEFT to stay on CR 27. When you see that sign, turn left, continue on CR 27. When you come down the big hill look for our white flags on the west (left) side of the road. If you get to lights at Ardagh, you've gone too far.

## EARNING POINTS:

The dog's time to complete the 100-meter dash is converted into KPHs (the CKC conversion chart is used).

A handicap system is applied based on the height of the dog at its withers (as per CKC)

Handicap: Under 12" = 2.0, 12"- 18" =1.5, Over 18 = 1.25

Points = KPH multiplied by the dog's handicap.

Sprinter Titles will be awarded for dogs that accumulate the required points. For purebred dogs, these are suffix titles that will appear on a dog's pedigree with a higher-level title superseding a lower level title.

Novice Sprinter (NS) = 150 points

Sprinter (S) = 500 points

Advanced Sprinter (AS) = 1,000 points

Sprinter Excellent (SX) = 1,500 points

SX followed by a number (e.g. SX@) for every additional 500 points



## Liability Agreement— By entering online participants agree to the following:

I (we) acknowledge that Simcoe Performance Dogs, The Red Barn Event Centre and Performance Dogs Canada has the right to refuse this entry for cause, which the organizing committee shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and win ribbons, or trophies, I (we) agree to hold this club, its members, directors, officers, agents, superintendents, sponsors of the events, or trial secretary and the owner or lessee of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the trial premises or grounds or near any entrance thereto. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, howsoever such injuries death or damage to property may be caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

### **Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the SPD/RBEC its employees, officiating judges, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any SPD/RBEC program.

\*\* It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

A non-member participation fee of \$62.40 plus HST will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

These events are open to mixed and unrecognized breeds. In order to compete, mixed and unrecognized breed dogs must have a Canine Companion Number (CCN) from the Canadian Kennel Club and must have a CKC-approved microchip. Mixed-breed dogs must be spayed or neutered. Unrecognized-breed dogs do not need to be spayed or neutered. A dog eligible for a CCN may not be entered as a listed dog. If a dog is not registered individually in the CKC studbook it may be entered as a listed dog per CKC rules for this designation, as of July 1, 2018; exhibitors must apply to the CKC for "temporary competition number (TCN), before event closing date". Effective January 1, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). This ERN does not register a dog for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with a cheque. Cost is \$62.40, plus taxes.

**Foreign Exhibitors:** Personal US cheques will be accepted in US funds, but due to fluctuating currency rates they cannot be discounted. Please do not mark personal foreign cheques "Payable" in Canadian Funds" or "At Par" as they will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Thank you.

#### **General CKC SPRINTER Information**

The Event Chairs are in full charge of the event. The Lure Operator will inspect the track to ensure no harmful objects within five yards on either side of the lure path. The Starter has control of the track in terms of ensuring dogs are on the line and all positions are ready.

**PLEASE STOOP TO SCOOP!** Anyone not picking up after their dog will be asked to leave and may be prevented from attending future events.

**SHOES:** Both Releaser and Catcher MUST wear closed toed shoes for safety.

**COLLARS:** Dogs may run with a flat buckle collar with no tags or attachments (no chokers, martingale or prong collars allowed); it is recommended to ensure collars are snug to prevent getting caught on anything during their run. Slip leads are recommended to bring the dog to the line. Flexis and electronic training collars or not allowed on the grounds. Owners may use clips or rubber bands to hold the dog's hair and may use muzzles to prevent destruction of the lure. Owners assume the responsibility for the safety of their dog with regard to the collar or anything attached to the dog.

**Eligibility:** SPRINTER participation is open to all purebred and mixed breed dogs at least 12 months of age that are individually registered with the CKC, or have an Event Registration Number (ERN) or a Performance Event Number (PEN) or eligible for the registration with the CKC or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed, or have a Canine Companion Number (CCN) if it's a mixed breed.
