Please check in with the Trial Secretary upon your arrival to the trial site and present each dog's registration card.

This titling event is being held under the rules of the **Sporting Detection Dogs Association**. Open to all breeds & mixes of dogs. Dogs must be registered with the SDDA and be over six (6) months of age. Please advise us in advance if you will be bringing a bitch in heat. Unofficial scent not permitted on the trial site.

**DOGS:** Dogs must be under control at all times. This is a fully public venue so please keep barking to a minimum, pick up after your dogs promptly and note that your dog **MUST** be on leash when not crated or in the search areas. Any handler displaying inhumane or aggressive treatment of any dog, the public or other handlers (physically or verbally) will be asked to leave the premises without refund.

All dogs must be on a flat collar or harness in the search area. Leashes must be cloth or leather of any length in the search area.

Competitors, through the submission of their entries, acknowledge that they know the Rules and Regulations. See Master Rule Book on the SDDA web site [www.sportingdetectiondogs.ca](http://www.sportingdetectiondogs.ca) to familiarize yourself with all rules.

Handler/Dog Teams may enter one or all components.

All three (3) components (Container, Interior, Exterior) must be successfully completed (qualifying scores earned) to earn the SD-S title; it is not necessary to complete all three on the same day, however. The honourific SP (Special) will be added to the title of any dog who does complete the three components on the same day, at the same trial.

**Crating** – There will be no indoor crating available. Please be prepared to work from your vehicle.

Please do not use address in GPS, use these GPS coordinates: lat 44.344860 long - 79.741025

From the 400: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go South on County Road 27.(aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From Hwy 27: When traveling North on CR 27 you must turn left shortly after passing through the town of Thorton. Look for the 20th Sideroad on your left and then the 10th Line on your right, that's your cue to slow down. Then you will see a small sign on your right that shows you must turn left to stay on CR 27. Turn left on CR 27 and continue north. After passing Mapleview Dr. W. you will go down a big hill, the Red Barn flags are on your left at the bottom of that hill.
