STAMP CARD

Drop in card enables applicant to attend any Klub K9, Puppy Practice, Scent and K9 Fit4Life drop in times. Each card is good for up to 10 drop ins. Fit4Life Drop in MAY require a 1 time fitness assessment per dog prior to drop in times (cost is extra). ALL equipment MUST be used for its intended purpose. Any dogs that come to drop in must be friendly. Dog socialization is not the purpose of drop in, but when it does occur it must be friendly. Cards are NON-TRANSFERABLE. Each person that works a dog(s) MUST have their own drop in stamp card. Cost is \$100 + HST which has 10 *interchangeable stamps*.

One stamp card can be used for Klub K-9, Puppy Practice, Scent AND K9 Fit4Life.
*****Monthly membership privileges such as crate storage & discounts are NOT applicable for card users.**
