**Entry Fees:** **\$20/run, 3 or more runs \$18/run, 6 or more runs \$15/run by the same handler**

**Day of trial entries** will be accepted based on space availability.... fees will be \$20/run

**Classes:** Beginner and Novice courses will have 15-20 obstacles. Hoopers uses mostly hoops. Parkour courses use a combination of hops, barrels, tunnels and gates. TunGo uses barrels and tunnels.

**Title Points:** A clean run earns 10 points at that level. A Beginner title requires 100 points. Bonus pts are available on clean runs by the Handler remaining inside a Distance Handling Box (DHB)(5-20 additional points) or staying behind the Challenge Line (CL)(5-15 additional points). More details are in the Rulebook. Novice – 200 points in Novice level in order to earn title and progress to the Intermediate level. Attendance. Participation and/or Entry into this event confirms acceptance of the attached Waiver and all aspects of the CHC Rulebook.
