Entries will not be accepted after the closing date and time, as per CKC regulations.

No mailed or emailed entries will be accepted.

Please note that if you are entering more than 1 dog, **you must complete your entry for all dogs at the same time.**

Entry fees, per dog per event

The CKC has increased their fees again this year. SPD has steadily absorbed the price increases over the years; however, this year we need to increase our fees to be able to provide the trials. Thank you for your understanding.

Before closing **April 2, 2026 @ 12 pm**.....\$28.00 each run, or **\$105.00 for 4 runs, same dog.**
For Fun Only (FFO) runs, when declared on entry form.....\$15.00 each run
Exhibition Only (*dogs not entered but on the event grounds*)..... **\$13.30**
TCN fee per dog per trial (charged by CKC)..... **\$11.30** each trial (there are 2 trials)

A Temporary Competition Number (TCN) is a number issued by the CKC that allows a dog of a recognized breed, eligible for CKC registration, to participate in CKC events.

Dogs that require a Miscellaneous Certification Number, Performance Event Number, or Canine Companion Number are not eligible for a Temporary Competition Number.

Please note each run entry fee includes the CKC Recording Fee of \$5.00 + HST

CKC has a Non-Member Participation Fee of \$64.00 + HST. This fee only applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

Payments must be received within 48 hours of entry or by closing, whichever is first.

You will receive a confirmation of entry usually within 48 hours of payment.

A judging schedule with trial starting time will be sent to all confirmed entries at least 6 days before the trial.

Please email dlmagility@gmail.com ONLY if you do not receive a confirmation of entry by closing date (or within 24 hours of entry & payment if entered within 24 hours of closing, or if you have a concern with the information on your confirmation.

No entries will be accepted, altered, canceled, or substituted after the official closing date and time for entries, except as provided in the rules. Exhibitors must abide by errors made in entering their dogs, regardless of how and by whom the errors were made.

There are NO extra fees for e-transfers. Please note that e-transfers sent to the wrong email are subject to a **\$10.00** charge. We will not be accepting any paper or emailed entries. All fees are payable in Canadian funds. Entries will only be accepted if accompanied by payment in full within 48 hours (if entry is less than 48 hours before closing, payment is due immediately). Confirmation and judging schedule will only be sent to entries that are accompanied by full payment. We do not accept cheques for payments.

"It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred."

The Trial Secretary, Dara Murphy, is in full charge of the trials. Trial precincts consist of the Red Barn property.

Whistles, clickers, "squeaky" toys, flexis, and prong collars are NOT permitted within 20 feet of any active agility ring, and no food or toys within 10' of the ring gates.

Non squeaky toys are permitted in ring with judge approval for FFO runs.

Bitches in season are NOT permitted anywhere on the trial precincts.

To be eligible to compete in these trials, a dog must be at least 18 months of age and eligible for a registration with the CKC, have an ERN or CKC Misc. Certificate, TCN or a CKC Performance Event Number. Spayed bitches, debarked dogs and neutered males are eligible to compete. Mixed breed dogs may enter these trials with a CKC Canine Companion Number.

NO OUTDOOR SHOES ARE ALLOWED IN THE BUILDING.

Handlers in all classes may walk the course without their dog prior to the start of their class. Obstacles shall meet the specifications in the CKC Agility Rules & Regulations effective January 1st, 2026. The broad jump and wall jump will not be offered at this trial.

HEALTH REMINDERS:

No dog may be brought onto the grounds or premises of an event if it:

1. Is known to have distemper, parvovirus, kennel cough or other communicable disease.
2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event).
3. Has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

Clubs do have the right to remove a dog from the event premises, and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

Running Order:

Novice warm-up run (optional run for dogs entered in novice standard run: \$10.00 (one run per dog allowed). Payment and entry at the trial.

Running Tall to Small

Ring is Top Dog rubber agility flooring with underlay. Ring enclosure is floor to ceiling walls (2 walls) 1 wall of 3 ft wood enclosure with plastic link fence gates and 1 wall of plastic link fencing. Ring dimensions are 90 ft x 90 ft.

Senior handlers 65 and older or handlers with a disability can request a modified course time or point requirement as of Jan. 1, 2020. Please ensure you check the box on the entry form (in Agility Rocks) to qualify for this if you wish.

Check-in: at the registration desk by the Red Barn front door.

NEW: Course maps: Course maps will be posted on the red “cage” wall; please feel free to take a picture. We no longer provide paper maps. Novice maps will be posted after the warm-up run.

Leashes: There will be a leash runner.

Move-ups: Move-ups will be allowed between events.

Volunteers & Course Building: All competitors are required to help with a minimum of 2 positions a day. If you can provide a volunteer, please email volunteer@redbarneventcentre.com

Results: Results will be posted on the “red cage”. They will also be posted on the Red Barn Event Centre website within 48 hours after the trial.

Ribbons: Qualifying and placement ribbons are self-serve from the box by the registration desk.

New title rosettes: will be offered at a cost of \$10.00 per rosette, exact change only & pick up before you leave. They are available at the registration desk.

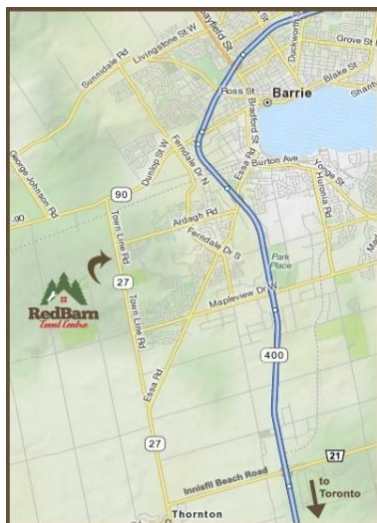
Refunds: Bitches in season may not compete or be on trial grounds. When a bitch comes into season after the entry has closed, a Vet’s certificate certifying the bitch was in season within a 10-day period preceding the trials must reach the trial secretary on or before the start of the first trial. A full refund of entry & listing fees will be given.

As of January 1, 2020, as per CKC regulations if a dog is injured after entry has been submitted to the Trial Secretary, a veterinarian’s certificate, certifying the dog was injured before a 3-day period preceding the trial, must reach the Trial Secretary on or before the start of the trial. The club will refund the entry minus the TCN fee and a 30% administration fee per trial.

If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trial, no refund of Entry will be made.

Vendors: Vendors or persons providing any services for a fee (including photographers) are not permitted to offer products or services without written permission from Simcoe Performance Dogs.

RV parking: We have limited 30-amp service for those wishing to bring RV’s, cost is only \$50 plus HST per day. Washrooms and shower available 24 hours to those that are camping. Please contact registration@redbarneventcentre.com for more details or to book.



**Directions to The Red Barn Event Centre:
8464 County Road 27, Barrie, ON L4N 9C4**

From the 400: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go South on County Road 27. (aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From Hwy 27: When traveling North on CR 27 you must turn left shortly after passing through the town of Thornton. Look for the 20th Sideroad on your left and then the 10th Line on your right, that’s your cue to slow down. Then you will see a small sign on your right that shows you must turn left to stay on CR 27. Turn left on CR 27 and continue north. After passing Mapleview Dr. W. you will go down a big hill, the Red Barn is on your left at the bottom of the hill.

To make everyone's visit a safe and enjoyable one, please respect Red Barn rules:

- 1) PLEASE drive slowly down the long driveway. 10 km limit!
- 2) There is a private residence at the front of the property. Do not walk your dogs down the driveway towards the residence as it upsets the dogs who live there.
- 3) Only park in the designated parking area.
- 4) Dogs must be on leash, except when competing in the ring. No exceptions.
- 5) No prong collars or flexi leashes are allowed on the Red Barn Event Centre property
- 6) Not all dogs love other dogs. Please keep your dog under control and out of other dogs' faces, even if your dog is friendly.
- 7) Please pick up your dog's waste. Disposal bags and sites are readily available. Green garbage cans are doggy waste only.
- 8) Please clean up after yourself. Please take home your garbage and recycling (other than doggy waste-green garbage bins).
- 9) No smoking or vaping anywhere on the trial site.
- 10) Please do your best to keep barking to a minimum
- 11) Be nice to our volunteers. Remember if you want to be treated with respect – give others the same respect.
- 12) Potty Incidents: There will be a \$20 clean-up fee charged to owners whose dogs' potty on equipment or other areas at the Red Barn. This offsets the cost of cleanup to equipment (agility equipment, mats, barriers, etc.), or replacement of equipment that cannot be effectively cleaned.**
