## GENERAL INFORMATION

This trial is being held under the Agility Association of Canada Inc (AAC) rules and regulations. Exhibitors by submission of entry, acknowledge that they are aware of these Regulations.

Move ups on the day will be permitted.

This trial will be held indoors on rubber flooring, Ring size is 90 ft. by 90 ft at the Red Barn Event Centre, Barrie, On. Agility Equipment will be chosen from those described in the AAC Rulebook. Rubberized contacts and E-timing will be used.

No unauthorized vendors or photographers.

### Eligibility

This trial's organizing committee reserves the right to refuse any entry and is in full charge of the trial.

This trial is open to all dogs being at least 18 months of age, including purebred and non-purebred, except bitches in season, dogs suffering from any deformity, injury or illness that may affect the dog's physical or mental performance, or dogs exhibiting signs of aggression towards people or other dogs.

### Refunds

There shall be no refunds for entries withdrawn after the closing date or in the event the dog is absent on the day of the trial. If the dog and/or handler are dismissed from competition, regardless of the reason for such dismissal, there will be no refund. Any handler who is found to abuse a dog will be disqualified and dismissed. Full refunds will be given for withdrawals before the closing date. Full refunds for withdrawals of bitches in season or injured dogs with a Veterinarian's note received by the trial secretary prior to the trial.

All competitors participate in the events at their own risk. The AAC General Agreement/Disclaimer must be agreed to on Agility Rocks in order to comply with AAC's acceptance and acceptance to this trial.

**DOG MEASUREMENT:** If your dog does not have one height measurement, it must be measured before it can run a course. Dogs 2 years and over need 2 measurements by two different judges on a permanent height card. If your dog is under 2 you need to show his ID card. Measurement will be sent in by the Red Barn and AAC will send you a temporary height card.

**PRIZES AND AWARDS:** In each of the Starters, Advanced, Master's rounds and all games ribbons will be awarded 1st to 4th in each height division. A flat qualifying ribbon will be awarded to all dogs that achieve a qualifying score in any class. New title rosette will be available for sale, for dogs earning a new title,

### **Fun Runs (aka WarmUps) - when offered**

The dog and handler will be allowed 75 seconds in the ring to follow their own route. Toys are permitted And food in a closed container. The dog must be entered in the trial. Only 1 Fun Run per dog.

**In order to make everyone's visit a safe and enjoyable one, we have just a few rules:**

- PLEASE drive slowly down the long driveway. 10 km limit!
- There is a private residence at the front of the property. Do not walk your dogs down the driveway towards the residence as it upsets the dogs who live there.
- Only park in the designated parking area.
- Dogs must be on leash at all times, except when competing in the ring. No exceptions.
- Not all dogs love other dogs. Please keep your dog under control and out of other dogs' faces, even if your dog is friendly.
- Garbage policy at the Red Barn "IF YOU BRING IT PLEASE TAKE IT HOME WITH YOU" There will be green bins around the property for the dog poop only and it must be in poop bags.
- No smoking or vaping anywhere on the trial site.
- Please do your best to keep barking to a minimum

- Be nice to our judges and volunteers. Remember if you want to be treated with respect – give others the same respect. We have a zero tolerance for any abuse of dogs or humans.
- Agility is a team sport, so please leave prong collars and other correction gear at home. Remember we enter the ring as friends and leave the ring as friends.
- “ If because of riot , civil disturbance or other acts beyond the control of management, it is impossible to start or to complete this event, no refund of entry will be made.”

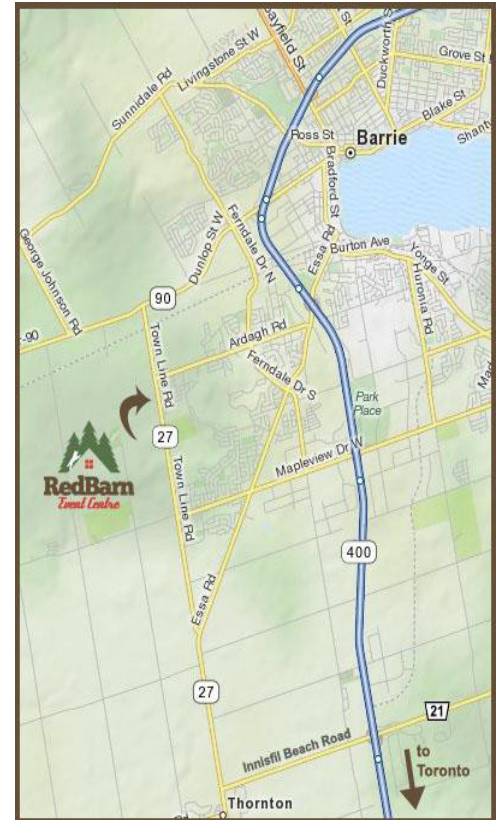
#### Directions to The Red Barn Event Centre:

**Please do not use address in GPS, use these GPS coordinates: lat 44.344860 long - 79.741025**

**From the 400:** Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go south on County Road 27. (aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

**From Hwy 27:** When traveling north on CR 27 you must turn left shortly after passing through the town of Thornton. Look for the 20th Sideroad on your left and then the 10th Line on your right, that’s your cue to slow down. Then you will see a small sign on your right that shows you must turn left to stay on CR 27. Turn left on CR 27 and continue north. After passing Maplevievw Dr. W. you will go down a big hill, the Red Barn flags are on your left at the bottom of that hill

I certify and represent that the dog entered is not a hazard to persons or other dogs. This entry is submitted for acceptance on the foregoing representation and General Agreement/Disclaimer. I agree to conduct myself (ourselves) in accordance with such Official Rules and Regulations (including all provisions applying to discipline) and to abide by any decisions made with them.

I agree that the organizations hosting this event (Red Barn Event Centre) has the right to refuse this entry for cause, which the organization shall deem to be sufficient.
