A TCN fee is payable for all dogs entered at trials who do not have an individual CKC registration number, an ERN, CCN or PEN. A TCN can be obtained at www.ckc.ca.

Catalogues: Catalogues are available on a PRE-ORDER basis. Those who wish to pre-order at a price of \$7.00 may do so by indicating this on their entry form. There will be a limited number of catalogues available for sale at the trial for a price of \$7.00 (exact change please).

Entry Information:

1. No entry will be accepted unless all particulars called for on the entry form are completed in full.
2. Incomplete entries will be rejected. No entry will be accepted until entry fees are paid.
3. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
4. Alterations, substitutions, or cancellations of any entry after the closing date is prohibited.
5. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are otherwise eligible for registration, can be entered. The committee reserves the right to refuse any entry subject to CKC Rules.
6. **ENTRIES POSITIVELY CLOSE AT 9PM ON TUESDAY JUNE 17, 2025, OR WHEN THE ENTRY LIMIT IS REACHED, WHICHEVER OCCURS FIRST.**
7. Judging schedules will be emailed as soon as possible after entries close.

Limited Entry:

Entry in each trial will be limited to the capacity of each judge to perform 7 hours of judging at the rate 15 dogs per hour less time for walk throughs in rally obedience. Once a judge has reached his/her capacity, entries for that trial will be closed even if the closing date has not been reached. In the case of the entry limit having been reached, remaining entries will be assigned a position (by class) on a reserve list. Exhibitors will be notified of their position on the reserve list. If the entry of a bitch in season is pulled after the closing of entries, it may be substituted with one from the reserve list up to and including the day of the trial. If the entry of another dog is pulled prior to the trial, it may be substituted with one from the reserve list up to 24 hours prior to the trial.

Eligibility to Compete:

To be eligible to compete in this trial, a dog must be at least 6 months of age and registered with the CKC or eligible for registration with the CKC, have a PEN, an ERN, a CKC MCN (Miscellaneous Certificate Number) or a CCN (Canine Companion Number).

Running Order:

Trial 1 will run in Ring 1, beginning with Master Class. Trial 2 will commence in Ring 2 beginning with Master Class immediately following the completion of the Master Class in Trial 1. Trials will run concurrently. Allowances will be made by the judges for ring conflicts between the trials for those entering multiple classes.

Rosettes and Ribbons:

Flat ribbons are awarded for qualifying scores only. A rosette will be provided for 1st to 4th in each class. New title rosettes will be offered for \$10.00 on day of trial only (exact change please). Summer Spectacular ribbons will be awarded to the High in Trial dog for each trial, as well as the top Senior dog in each trial. High Combined dog in each CKC Event will also be awarded. An Iron Dog rosette will be awarded to the top dog competing in three or more disciplines over the course of the Summer Spectacular event. Junior handlers will be awarded special gift bags.

Bitches in Season Rule 6.5:

Bitches in season are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's Certificate, indicating that the bitch was in season within ten days of the trial, must reach the Trial Secretary before the trial commences. The club will refund entry fees. Note that we are unable to refund the online service charge portion of the fee.

Indignities - Rule 20.7:

It shall be the duty and obligation of the trial-hosting club to see that any judge, club official, ring steward, volunteer, or competitor at a Rally Obedience Trial held under these regulations, is not subject to indignities of any kind. The Rally Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

General Information:

1. The Trial Chair will be in full charge of the trial, governed by the rules of the CKC and the Red Barn Event Centre.
2. Simcoe Performance Dogs will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability, in the event of accident, or other misfortunes, to either dogs or humans.
3. If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trial, no refund of Entry will be made.
4. The trial precincts shall be the entire building and grounds of the Red Barn Event Centre.
5. Request for refund for any reason other than Bitch in Season will be handled on a case-by-case basis. Request must reach the Trial Secretary before the trial commences. Supporting documentation may be required. Note that we are unable to refund the online service charge portion of the fee.

Health Reminders Rule 6.6:

No dog may be brought onto the grounds or premises of an event if it:

1. Is known to have distemper, parvovirus, kennel cough or other communicable disease, AND/OR
2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease within 30 days prior to the event, AND/OR
3. Has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

The Club has the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

Rally Obedience Trial Rules and Regulations:

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the CKC Obedience and Rally Rules and Regulations Effective January 2024. Potty Incidents: There will be a \$20 clean-up fee charged to owners whose dogs' potty on equipment or other areas at the Red Barn. This offsets the cost of cleanup to equipment (agility equipment, mats, barriers, etc.), or replacement of equipment that cannot be effectively cleaned.

CKC has a Non-Member Participation Fee. This fee only applies to dogs wholly owned by nonmember residents of Canada and is not applicable to CKC members. In order for a title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

Overnight RV Parking:

A limited number of spaces with 30 amp service are available for those who wish to bring RV's. Washrooms are provided 24/7 for campers. Please see the Event page for the RV form.

RED BARN INFORMATION:

There is a private residence at the front of our property. PLEASE respect this and proceed slowly down the long driveway. 10 kph limit! Please do not walk dogs down the driveway. It disturbs the dogs who live there.

Please park in designated areas only.

Check in is at the main entrance Registration desk when you arrive. Staff will be available to assist you if needed. Course maps will be available at check in.

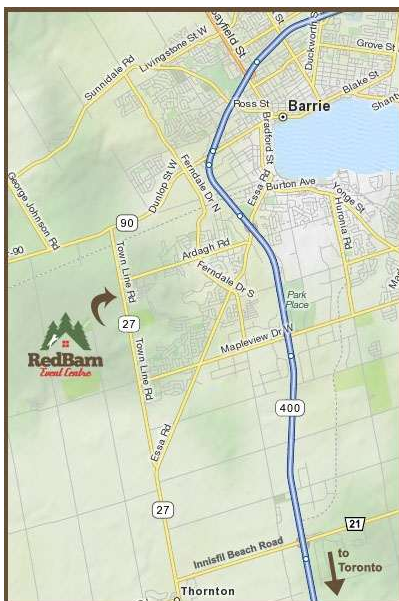
ALL shoes MUST be changed to clean indoor shoes and dog paws cleaned/dried off in the entrance area of the facility.

There is space available for crating indoors at the Red Barn on a first come, first served basis. You may also crate from your vehicle, but we cannot allow your dog to bark constantly while in your car, and we do not call out names in the parking lot when it is your turn. All dogs must be crated or on leash when not in the ring (x-pens are allowed). Handlers are responsible to keep their dogs quiet at all times, clean up after their dogs and exercise them in appropriate areas only. There will be containers to dispose of dog waste, but we ask that you take your other trash home with you.

No prong, spike, or shock collars are permitted on the property.

Any dog engaging in aggressive behavior at any time will be required to leave the trial grounds without refund.

From the 400 Southbound: Take the Essa Road exit 94. Turn west on Essa (sign says Essa Road South). Take the first right at Ardagh Road. Follow Ardagh to the end at County Road 27. Go South on County Road 27 (aka Town Line Road). Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From the 400 Northbound: Take the Innisfil Beach Rd exit 85. Turn west at the lights onto Innisfil Beach Rd. and continue to CR 27 in Thornton (the road will end). Turn right onto CR 27 and head north for 3.2km, then turn left to stay on CR 27 (the sign is small). Look for the 20th Sideroad on your left and then McKay Road on your right, that's your cue to slow down. Continue north on CR27. After passing Mapleview Dr. W. you will go down a big hill, the Red Barn is on your left at the bottom of the hill. Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.
